Advanced Weapons & Equipment India Ltd. (AWEIL) is a Scheduled ‘A’ Defence Public Sector Undertaking under Department of Defence Production, Ministry of Defence, Government of India, with Corporate Hqrs at Kanpur, incorporated under the Companies Act 2013 on 14th August, 2021. It has commenced its business on 1st October 2021 notified by DDP. Advanced Weapons and Equipment India Limited (AWEIL), is primarily engaged in Manufacture and Supply of Weapon Systems, Small Arms, Tank Gun Articles and Ammunition Components and has eight production units spread across various states in India.

AWEIL invites applications from Indian nationals fulfilling the following eligibility criteria for the following post:

b	Essential Qualification	1. The candidate should possess the Bachelor’s in Law(LLB) with minimum 60% marks from a recognized University and/ or Institute in India duly recognized by the Bar Council of India with minimum 60% marks. 2. Candidate should be registered in Bar Council anywhere in India.
c	Desirable Qualification	Master of Laws and higher qualification will be preferred.

d	<b>Experience</b>	<ol style="list-style-type: none"> <li>1. Post qualification of 3 Years' experience in Legal work experience in Central Govt./State/ PSU/Statutory Body/reputed non-government organization.</li> <li>2. The candidate should possess thorough knowledge of laws pertaining to corporate, commercial, labor and industrial, taxation, land acquisition, contract and arbitration etc.</li> </ol>
e	<b>Preference</b>	The candidate should have excellent written and oral communication and interpersonal skills. Knowledge of Computer applications such as MS word, MS Excel, Power point etc. are essential.
06	<b>Place of Posting</b>	AWEIL Corporate Office. However, he / she may be deputed for official works to any of the units of AWEIL/Govt. offices /Departments. Based on the requirement he/she may be transferred to other unit/office of AWEIL.

09	<b>Accommodation</b>	Company Quarter will be provided, if available and necessary deduction will be made as per Company rules.
10	<b>Selection Process</b>	Educational Qualification, Experience and performance in personal Interview. The Competent Authority may enhance the criteria for qualification and /or experience to shortlist the candidates for interview in the event of large no. of candidates fulfilling the eligibility criteria particularly to the above-mentioned post.
11	<b>Process of Interview</b>	The interview will be conducted by a duly constituted selection committee.
12	<b>Working Hours</b>	As per office timing of AWEIL HQ and AWEIL unit in which he / she is posted. If required, as per exigencies of work, he / she would be asked to attend office on Saturday or other holidays without any additional compensation.

13	<b>How to apply</b>

Only hard copy of application is acceptable.</b>
b	Hard copy of the Application is to be submitted along-with 2 self-attested recent passport photographs (with full name written on the backside for identification) and also self-attested copies of documents/certificates in support of claim regarding age (Birth Certificate / 10th Class Certificate), qualification, experience, etc.
c	It is mandatory to fill all the relevant information such as qualification, experience, percentage of marks, email address, contact mobile number, address for correspondence, AADHAR card number/PAN Number etc.
d	Non- attachment of required documents as per the format will be treated as incomplete application and hence rejected forthwith.
e	The applicant should affix his/her one passport photograph in 4.4 cm x 5.8 cm dimensions on the application in the space provided. The Second one should be attached with it and not pasted.
f	In case of variation of Name/ surname/name, spelling mentioned in the Application cum Bio-data with that of educational/ professional qualification certificates, application is liable to be cancelled.
g	Applicant is requested to enter his/her active email address and mobile phone number which should be valid at least till the interviews are held, as all important communications will be sent to this email id and Mobile number.
h	Candidates who are working in Public/Govt. Sector should forward their Applications through proper channel clearly indicating their mode of recruitment, present grade and present scale of pay separately or NOC should be submitted at the time of interview, in case selected, failing which their candidature will be rejected.
i	AWEIL management will not take any responsibility for any delay in receipt or loss in postal transit for any application or communication.
<b>14</b>	<b>Terms &amp; Condition of Appointment</b>
a	Candidate must be citizen of India.
b	AWEIL reserves the right to reject any application/candidature at any stage without assigning any reason and the decision of AWEIL shall be final.
c	The appointment shall be purely temporary and on contract basis. The candidate's services can be terminated by AWEIL by giving 1-month notice or with remittance of one month's pay in lieu thereof. If candidate wishes to leave the services of AWEIL, he shall have to give three months' notice to AWEIL or pay three months' salary in lieu thereof.
d	The successful candidate will have to sign a contractual agreement in the prescribed format.
e	The Contract shall not confer any rights or claim of extension/absorption in the Company.

f	Candidates currently serving in Govt. / Quasi. Govt. / Public Sector Undertakings are advised to seek prior permission/NOC from their employer to apply for the notified vacancy. Such applicants shall have to submit 'No Objection Certificate' from their employers at the time of interview, failing which they shall not be allowed to appear in interview and their candidature shall be treated as cancelled.
g	On final selection, such a candidate who has been working in Govt./PSU/private entity, should produce the document conveying the acceptance of his resignation from service or his last employer. In the absence of such document, he shall not be allowed to join AWEIL Service.
h	The decision of the AWEIL about the mode of selection, eligibility conditions, short listing of candidates for interview etc. shall be final and binding. No correspondence will be entertained in this regard.
i	The candidates called for interview shall be required to produce original documents relating to educational qualifications, experience etc. for verification at the time of interview. If the identity of the candidate is in doubt or he is not able to produce the requisite documents or there is mismatch of information in the documents or he is found ineligible for the post applied for any other claim made in his application if found to incorrect, he will not be allowed to appear in the interview and his candidature will be treated cancelled.
j	Candidates are advised in their own interest that they should not furnish any documents or information that are false, tampered, fabricated and they should not suppress any material information while filling up the application Form.
k	At any stage of recruitment or later, if a candidate is or has been found guilty of any misconduct as:
1	Impersonating or procuring impersonation by any person; or
2	Resorting to any irregular means in connection with his/her candidature during selection process; or
3	Using undue influence of his/her candidature by any means; or
4	Submitting or false certificates/documents/information or suppressing any information at any stage; or in addition to rendering himself/herself liable to legal/criminal prosecution, will also become liable to be Debarred permanently.
5	Can be discharged/removed/dismissed from service, if the act of misconduct comes to notice after his/her appointment to service of AWEIL.
l	Decision of the AWEIL in all matters regarding eligibility of the applicant, the stages at which such scrutiny of eligibility is to be undertaken, documents to be produced, personal interview, selection of any other matter relating to engagement will be final and binding on the applicant. While applying for the post, the applicant should ensure that he/she fulfils the eligibility and other criteria mentioned and that the particulars furnished are correct in all respect. In case it is detected at any stage of recruitment that applicant does not fulfill the eligibility norms and/or that he/she has furnished any incorrect/false information or has suppressed any material fact (s), his/her candidature will automatically stand cancelled. If any of the said shortcoming(s) is/are detected even after recruitment, he/she is liable to be terminated without any notice.
